



Adventures in Tail Wagging Service Contract

Adventures in Tail Wagging provides high quality in-home pet sitting and dog walking services. For purposes of this contract, the term "Client" refers to the pet guardian and/or homeowner who is/are engaging the services of *Adventures in Tail Wagging*. The term "Pet" (in both singular and plural forms) means any animal under the care of *Adventures in Tail Wagging*. According to the terms set forth herein, I, _____, direct *Adventures in Tail Wagging* to take care of the pet(s) identified on the attached profile on the following dates: _____.

Emergency Care

I, _____, authorize emergency medical care to be provided for my pet(s) by the following veterinarian: _____.

In the event that my veterinarian is not available, or closer care is available, I give *Adventures in Tail Wagging* permission to approve treatment up to \$_____ (specify dollar amount or "no limit"). I agree to be responsible for all charges including, but not limited to, veterinarian fees, extra visits, medications, and transportation fees. I will reimburse *Adventures in Tail Wagging* for any charges incurred related to emergency care.

Pet Health and Temperament

I attest that my pet(s) is/are up-to-date on all vaccinations and that my pet(s) do/does not suffer from any life-threatening or contagious conditions that may be exacerbated by exposure to other pets, or expose other animals to undue risk while in the care of *Adventures in Tail Wagging*. Further, I attest that my pet(s) has/have not harmed or shown aggressive or threatening behavior towards any person or any other dog.

Keys & Home Access

Keys to the home, apartment key cards, and/or garage door, security alarm and apartment building codes are required for all services. Generally keys will be collected at time of contract signing, but the Client may choose to leave a key for pick-up around the premises of the home as specified by the Client. Any locksmith fees incurred as a result of providing faulty keys, or no keys at all, is the financial responsibility of the Client. All garage, security, and apartment codes will be collected at the time of contract signing.

Payment

Cash or Checks accepted. Payment is due within five (5) days of billing. If payment is not received in full within thirty (30) days, collection proceedings will begin on the client's account. Clients are responsible for all reasonable attorney's fees and costs associated with collection.

Additional Fees

If supplies that are required for services to be rendered are not made available by the client (e.g., food, leash, cat litter), *Adventures in Tail Wagging* will provide these supplies in order to render the service(s) requested and the client will be responsible for reimbursing *Adventures in Tail Wagging* the full cost of these supplies.

Cancellations

Dog walking and Pet Taxi cancellations require 24 hours notice. If less than 24 hours notice is given before the time of service, the client will be charged a \$10 late-notice fee. Pet Sitting cancellations require five (5) days notice. If less than five (5) days notice is given, client will be billed 25% of the scheduled visit costs. If less than 24 hours notice is given, client will be billed 50% of the scheduled visit costs.

Release/Waiver

I understand that potential harm could occur to my pet, or to my home, while in the care of *Adventures in Tail Wagging*. I agree to release and hold harmless *Adventures in Tail Wagging* from all liability, should my pet(s) become lost, injured, or otherwise harmed; likewise, I release and hold harmless *Adventures in Tail Wagging* should my home suffer any damage *not* due to negligence on the part of *Adventures in Tail Wagging*.

Adventures in Tail Wagging agrees to exercise all due and reasonable care to prevent injury, illness or death to my pet(s) and prevent harm to my home in my absence. However, in the event of injury, illness or death, or damage to my home, except those caused by reckless or negligent acts on the part of *Adventures in Tail Wagging*, the company shall not be liable for such injury, illness or death, or damage to my home.

Understanding the risks as stated above, I freely and voluntarily enter into this contract, including the release and waiver, with *Adventures in Tail Wagging*. This contract is a full and complete instrument. No other warranties expressed or implied are valid unless stipulated above. I have read this service contract, including the release and waiver, and understand the contents of this form.
